I assume these two referrals relate to the two requests I made to him during the meeting you and I had with him on June 16th last: which were **a)** "talking therapy" for the Complex-Post Traumatic Stress Disorder I am suffering from, and **b)** training relating to a different way of handling my prostate problem.
