## RE: Registered Letter to Mr Brendan Glynn dated October 12th 2020

Thank you very much for calling to see me again yesterday.

After yesterday's meeting, I got the feeling that it might be important for me to let you know that, to date, I have not received any reply of any kind from anybody at the Republic of Ireland law firm of Patrick Hogan & Co (Ballinasloe, County Galway), to the letter I sent to lawyer Mr Brendan Glynn on October 12th 2020.

Scanned copies of the associated Royal Mail receipt, and of the associated Royal Mail "Proof of Delivery Note", can also be viewed at the above www location.

Please know that unless, and until, such time as I am in receipt of a meaningful written reply from Patrick Hogan & Co to the following two questions, also referred to in the scanned copy of the registered letter referred to at the above www location -- *i.e. a) why did Patrick Hogan & Co refuse to legally secure the loans against my home around the time the loans began in 2007; and, b) why did solicitor Brendan Glynn fail, without any reasonable explanation to date (that I know of), to appear on behalf of myself, my brother, and my half-sister at the Loughrea District Court hearing on July 8th 2015 -- I would not wish Patrick Hogan & Co to be involved, while acting on my behalf that is, in any of the efforts you are working on for the purpose of trying to resolve the Radius Housing Association rent arrears debt of mine: which at present stands at approximately £7,330, and which is growing at the rate of approximately £103 per week.* 

Finally, I wish to make it clear that, assuming you might consider it appropriate to do so on my behalf, I would have no objection to either of you contacting Patrick Hogan & Co regarding the above matters.
