Please know that I have asked the Housing Executive to be considered for the "**complex needs**" type of "**sheltered accommodation**"; and, that this is because the complicated set of legal and medical problems I have attempted to outline in the email I sent to Niall Fitzpatrick on November 21st 2016, which I need to remedy, and which, despite my very best efforts over a period of several years, are proving far too difficult for me remedy by myself.
