Section 1 of the letter to Dr Bell at the www location just above contains information relating to my wish to be able to return to live in my home in the Republic of Ireland (located in the village of New Inn, County Galway).

Section 1 also contains reference of my legal right (as I understand it) to seek asylum in Northern Ireland, under the terms of Article 18 ("The right to asylum") of the CHARTER OF FUNDAMENTAL RIGHTS OF THE EUROPEAN UNION. Consequently, I do not understand why it should be necessary form me to have to sell my home in the Republic of Ireland in order to have my Pension Credit payments, and my Housing Benefit payments, restored.
