A GLOBAL EMANCIPATION PROCLAMATION
MADE UNDER THE LAW OF GOD AND MAN

**Invoking the Legal and Spiritual Disestablishment of the Church of Rome

**Issued as a Binding De Jure Annulment and Emancipation Order by The
International Common Law Court of Justice and The Covenant of Free
Congregational Christians on Easter Sunday the 20th Day of April in the year
2014**

TO BE PUBLICLY PROCLAIMED AND ENACTED

Let it Be Known and made effect by all men and women, persons and authorities that under the Supreme Law of God as embodied in the Common Law of Nature and Natural Right, as of this day, the institution and entity of the Church of Rome, its officers, clergy, adjunct and derivative bodies and corporate entirety, is now and forever abolished and disestablished as a corporate and a spiritual body. All people and powers formerly under its authority and influence and owing it allegiance are now and forever emancipated and freed from such obligatory servitude.

Having violated and waged unrelenting war on God and humanity through its history of crime, murder, apostasy, child sacrifice and idolatry, and thereby repudiated its covenanted requirement of duty to uphold the honor of Heaven and Earth, and the life and dignity of mankind, the Church of Rome has nullified its basis for existence and brought upon itself the status of a renegade transnational criminal organization in the eyes of God and man, and under the laws of both heaven and earth.

The ultimate authority of God as expressed in *De Jure* common law courts of judgment and in congregations of just, truthful men and women does therefore nullify the existence of the Church of Rome, the alleged “Apostolic Succession”, and its so-called “Canon Law”.

Therefore, as of this day, all such law, statutes, and all church offices and officials are declared to be forever abolished and possessing no effect or binding authority in heaven or on earth.

All Church of Rome officials and agents, commencing with Jorge Bergoglio, so-called Pontiff of the Church of Rome, every Cardinal of the Roman Curia, the heads of the Vatican Bank and Adolfo Pachon, chief “Superior” of the Jesuit Order, are hereby ordered to immediately stand down from and relinquish their offices.

The wealth, property and movable assets of the Church of Rome are hereby forfeited and declared to be under the common ownership of the People of the world, and may be peacefully seized and occupied by them.

Every member, employee and adherent of the Roman Catholic Church is hereby released from all of their vows, allegiance and obligations to the Church of Rome, and are freed to gather and worship in whatever congregational form that God and their conscience compels, separate from the disestablished Roman church.

The sheriffs and peace officers of lawful common law courts, assisted by the free people of the world, are henceforth authorized and encouraged to enact and enforce this Annulment and Emancipation Proclamation wherever possible, under the supreme and sovereign authority of God and the Law of Nations.

The people of God who have been lost and held in bondage within the spiritual captivity of the false church of Rome are now free to assemble in covenanted congregations which stand solely under the law of God and recognizing no other legitimate authority, for the establishment of God's kingdom on earth.

The long night of spiritual tyranny and Vatican crime is over. Let the free people of the Earth and all true servants of God and Christ cleanse their lands of the Lie and the Murder formerly enthroned in Rome.

PUBLIC NOTICE OF TREASON AND ORDER TO COMPLY

ISSUED AGAINST THE OFFICE AND AGENTS OF THE CROWN OF ENGLAND BY THE PEOPLE ASSEMBLED IN COVENANT UNDER THE COMMON LAW ON THIS TWENTY FIFTH DAY OF FEBRUARY IN THE YEAR 2014

LET IT BE FURTHER KNOWN that all legal agents of Elizabeth Windsor, the British Monarchy and the former Crown of England are hereby and forever released from their oaths of allegiance to these persons, flesh and blood men and women and bodies Corporate, and from all duty and obligation to the same, and are placed instead under the authority and jurisdiction of the People assembled by Covenant under the Common Law, this Order being applied to all police officers, clergy, judges, soldiers, Members of Parliament, civil servants and other Crown Officers; and



LET IT BE KNOWN that on the following three criminal counts – of committing and conspiring to commit crimes against humanity, of subverting the Law of Nations, and of inciting treason, child trafficking and warfare against other peoples - the Vatican and its chief officers including Jorge Bergoglio, aka Pope Francis, are engaged in and have been lawfully found guilty of Treason, Fraud, Tyranny and Warfare against the People; and


LET IT BE FURTHER KNOWN that accordingly, the laws, statutes, authority and position of these persons, flesh and blood men and women and bodies Corporate are now and forever nullified and made void, being part of a Criminal Organization and Conspiracy against the lives, liberties and well being of the People; and

LET IT BE FURTHER KNOWN that all legal agents of the Vatican, the Church of Rome and Jorge Bergoglio, aka Pope Francis are hereby and forever released from their oaths of allegiance to these persons, flesh and blood men and women and bodies Corporate, and from all duty and obligation to the same, and are placed instead under the authority and jurisdiction of the People assembled by Covenant under the Common Law, this Order being applied to all clergy, Bishops and Cardinals, church officials and members, Vatican police officers and all other church agents; and

ON THIS TWENTY FIFTH DAY OF FEBRUARY IN THE YEAR 2014**


LET IT BE KNOWN that under the authority of Natural Law and the customary liberties of the People, the International Common Law Court of Justice and its affiliate courts do hereby authorize the establishment of duly sworn Peace Officers and Sheriffs to act as the police and enforcement arm of the Courts, and to replace the former police agencies of the disestablished criminal bodies known as the Crown of England and the Vatican.


LET IT BE FURTHER KNOWN that these Common Law Officers and Sheriffs shall have universal jurisdiction and authority to serve Court Summonses and Warrants, make arrests, enforce Court verdicts and sentences, and generally police, protect and ensure the lawful operation of the Courts. These Peace Officers and Sheriffs are subject to no authority or jurisdiction save that of the Common Law Courts and the People assembled in Covenant, who shall establish the statutes and protocols by which these Officers and Sheriffs shall operate.

LET IT BE FURTHER KNOWN that these Common Law Officers and Sheriffs shall have the power to deputize any man or woman, including the peace officers and agents of other regimes, to serve as the legal agents of the Courts and to enforce their Orders; and they shall also have the power to arrest and detain any former or existing agents of convicted criminal bodies such as the Vatican and the Crown of England, and other declared Enemies of the People.

PUBLIC NOTICE AND LEGAL INSTRUMENT

THE CROWN OF ENGLAND, THE GOVERNMENT OF CANADA AND THE ROMAN CATHOLIC, ANGLICAN AND UNITED CHURCH ARE LAWFULLY DECLARED TRANSNATIONAL CRIMINAL ORGANIZATIONS UNDER INTERNATIONAL LAW

AS OF SEPTEMBER 1, 2013, THEIR AUTHORITY, LAWS, PROPERTY AND ASSETS ARE FORFEITED AND NULLIFIED

Under a verdict of the International Common Law Court of Justice dated February 25, 2013, and the Protocols of the United Nations Convention against Transnational Organized Crime (2000), these organizations have lawfully been found guilty of Genocide, child trafficking, Crimes against Humanity, violating the Law of Nations, and inciting their members to aid and abett these crimes.

Accordingly, the jurisdictional authority of these governments and churches and their courts is now and forever null and void *ab initio*. Their orders and statutes have no binding force on any person or corporate body, and are to be ignored.

All police, judicial, political and other officials are hereby released from their oaths of obligation to these criminal bodies and their former chief executive officers and agents. No-one may legally fund or associate with these criminal bodies or their fugitive leaders, and the property and assets of these bodies may be lawfully seized and occupied by the citizenry. Any person may perform Citizens' Arrests on the officers of these criminal bodies, especially known or suspected child rapists.

This Public Notice is issued to you as a lawful warrant by the Common Law Court of Justice, placing you under the jurisdiction of the Court and Natural Justice, and deputizing you as its officers.

CANADA IS DISSOLVED

A Legal Notice to the People of Canada and to all agents of the so-called Crown of England

Issued by the International Common Law Court of Justice, Brussels

LET IT BE KNOWN, that on February 25, 2013, our lawfully constituted Court and its fifty eight sworn jurors found Elizabeth Windsor, Queen of England and Head of State in Canada, guilty as charged of Crimes against Humanity and of engaging in a Criminal Conspiracy to obstruct justice and conceal her personal complicity in the permanent disappearance of ten Canadian children.

This verdict, which also found guilty former Pope Benedict, Prime Minister Stephen Harper and other officials of church and state, was based on irrefutable evidence of their role in the deaths of over 50,000 aboriginal children through Crown-established and church-sponsored internment camps. Neither Elizabeth Windsor nor any of the defendants denied or contested this evidence, nor did they respond to the Public Summons issued to them. Accordingly, the Pope, the Queen and the Prime Minister were sentenced in absentia to twenty five years imprisonment and a loss of all authority, assets and property.

Our Court's verdict rests upon the Nuremberg Legal Statutes which allow any head of state to be tried for crimes against humanity, as well as the right under Canadian law to hold the Crown liable for tort offenses committed in Canada.

Elizabeth Windsor, as a convicted felon, is not only liable for immediate arrest and imprisonment, but has forfeited any legal or constitutional authority. All constitutional arrangements and Nations based on the authority of the Crown of England have accordingly been legally dissolved.

Therefore, Canada has been rendered as a state without legitimate legal or political authority. It will remain so until a new and lawful Head of State and Constitution can be democratically established by the people of Canada.

As of this date, all agents of the former Crown of England are released from their obligation and allegiance to that Crown and the government of Canada, including all Members of Parliament, judges, civil servants, the police, and the military. All courts, laws and statutes based upon the Crown and former Dominion of Canada are similarly disestablished and their power is nullified.

Until a legitimate government and law is established in Canada, citizens are obligated to conduct themselves under the inherent common law requirement of

equity, peaceable co-existence and self-government, maintaining their own law and order within their communities. For all existing political, legal and police authorities in Canada are illegitimate and inoperative.

As self-governing men and women, citizens are obligated to convene a National Congress to draft a new Constitution for a sovereign Republic of free citizens. This Constitution, established in such a Congress, will be ratified by a popular vote, and will establish a new democratic Republic in Canada.

The new Constitution will include a legal framework to ensure that all of the convicted parties in our case of genocide in Canada will similarly be disestablished as corporate bodies, including those churches responsible for Genocide and Criminal Conspiracy in Canada: namely, the Vatican/Roman Catholic church, the Church of England, and the United Church of Canada.

Our Court has entered this verdict and statement into its permanent record, and issued it to all of the governments of the world and to the United Nations. As such, this Public Notice constitutes a legally enforceable document that may be used by the Bearer to uphold his or her status as a freeborn man or woman within Canada who is not subject to any authority or law save as a Citizen of a democratically constituted Republic in Canada.
