RE: SEPTEMBER 18TH 2015 DEADLINE FOR INFORMATION YOU HAVE REQUESTED

1) Pension Credit Application:

To date, I have not heard anything at all from the people who I understand are dealing with the **Pension**Credit application I submitted on August 6th 2015 (by hand to the person who helped me fill in the form) at the Newry Benefits Office (in Phoenix House, 40 Bridge Street). It is my understanding that my completed Pension Credit was then to be forwarded, by Newry Benefits Office staff, to the Northern Ireland Pension Centre in Derry. However, I have never – to date – received any acknowledgement of receipt from anybody for my Pension Credit Application of August 6th 2015. I have called in a number of times to Phoenix House (Newry) to enquire about progress, and it is my understanding – based on what I have been told – that my Pension Credit has been received by the Northern Ireland Pension Centre in Derry (on August 14th 2005), and that arrangements have been put in place for it to be processed as a matter of urgency. When I still had heard nothing by the end of last week, I applied for another "Crisis Loan" on September 11th 29015, and I spoke with Mickey Mc Givern (Acting Crisis Loan Supervisor), at some length, regarding my overall situation: including the deadline you have set (of September 18th 2015). As I understand it, Mickey Mc Givern then spoke on the phone to somebody at the Northern Ireland Pension Centre in Derry (on September 11th 2015), and that he was assured that my claim was being processed as a matter of urgency. Nevertheless, I have still not heard anything further (from anybody) regarding the matter.

It is also the case that difficulties arose in connection with my application for a "Crisis Loan" on September 11th 2015, and this — it seemed to me — may be due to the fact that Mickey Mc Givern (and his colleagues) are possibly be treating the monthly loans I have been receiving for the past several years from my brother (Gerald Finnerty) as "income": and <u>NOT</u> as "loans", which is how I am inclined to think they should be viewed.

As it appeared to me that Mickey Mc Givern was largely unaware of certain very important (as I see them) aspects of my <u>overall</u> situation, I sent him some "outline information" (using a registered letter) regarding my overall situation, just after my meeting with him of late last Friday (September 11th 2015) afternoon, which was the second of two meetings I had with him on that day, had ended. 2) Proof that the value of the property I own in County Galway is less than the outstanding loans:

Also, I feel I should mention that, for security reasons, I have edited out parts of my present address information in the papers at the "PDF" www addresses referred to in this email.

I have since received a reply from my brother and half-sister, and scanned copies (in PDF Format) of their four-page reply, together with a one-page "covering note" written by myself, can be viewed at the following www location:

Also, I have received a formal valuation for the property I own in County Galway from local (East County Galway-based) Valuer and Auctioneer Vincent Costello, and scanned copies of the related papers can be viewed (in PDF Format) at the following www address:

As can be seen at the two www above addresses immediately above, my outstanding loans (no my brother and half-sister) – as of August 10th 2015 – against my now derelict home ("St Albans") in New Inn village (County Galway) are Euros 65,000; and, the property has been formally valued at Euros 35,000.

Should you require any further information from me regarding the contents of the two PDF files immediately above, please let me know.

I would be very grateful if you could please extend the deadline for the "Pension Credit decision" information, referred to under "Section 1" above, and which I have not yet received. I would also very much appreciate it if you could advise me of your decision regarding this particular matter please; and, if appropriate, provide me with the date of any extension which you may be willing to grant.
