I suffer from **Complex-Post Traumatic Stress Disorder (C-PTSD)** as a direct result of the **years of extremely serious criminal abuse** which I have been subjected to by the Government of the Republic of Ireland, in response to my efforts to challenge **extremely serious wrongdoing by the Government of the Republic of Ireland.**

For **evidence** of the above-mentioned allegations, please see the attached copy of the **"To Whom It May Concern Letter"** dated **October 28th 2005** from **Dr Michael McCavert GP.**

Despite my very best efforts since October 28th 2005 (and for several years before then), I have still not succeeded in finding legal representation of the kind which recognises the factual existence, in practical ways, of national and international legislation based on the United Nations Universal Declaration of Human Rights (1948); and, without such legal representation, I know of no way of recovering from the C-PTSD injuries I am suffering from.

Any help your organisation might be able to provide me with, for the purpose of finding the kind of legal representation I need, would be very much appreciated.

#### UNITED NATIONS UNIVERSAL DECLARATION OF HUMAN RIGHTS (1948)

From the PREAMBLE of the text at the UN [www](http://www.un.org/en/documents/udhr/) address just above:

"Now, Therefore THE GENERAL ASSEMBLY proclaims THIS UNIVERSAL DECLARATION OF HUMAN RIGHTS as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society, keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction."

So what happened? Why have so many governments (possibly all of those who have "signed up" during and since 1948) failed – thus far – to follow the very strong suggestion in the section of the PREAMBLE reproduced above that **"EVERY individual and**

**EVERY organ of society", "shall strive by teaching and education to promote respect for these rights and freedoms"?"**

I suspect, for example, that despite all of the very long string of "troubles" we have had here in Ireland since **1169 AD**, which have been very largely caused (I believe) by massive violations of the most basic and most fundamental "human rights", less than 5% of "the people" living on the Island of Ireland at the present time have ever even heard of the UNITED NATIONS UNIVERSAL DECLARATION OF HUMAN RIGHTS (which was "declared" on December 10th 1948).

*"The Universal Declaration of Human Rights (UDHR) is a declaration adopted by the United Nations General Assembly on 10 December 1948 at the Palais de Chaillot, Paris. The Declaration arose directly from the experience of the Second World War and represents the first global expression of rights to which all human beings are inherently entitled. The full text is published by the United Nations on its website."*

*"The Declaration consists of thirty articles which have been elaborated in subsequent international treaties, regional human rights instruments, national constitutions, and other laws. The International Bill of Human Rights consists of the Universal Declaration of Human Rights, the International Covenant on Economic, Social and Cultural Rights, and the International Covenant on Civil and Political Rights and its two Optional Protocols. In 1966, the General Assembly adopted the two detailed Covenants, which complete the International Bill of Human Rights. In 1976, after the Covenants had been ratified by a sufficient number of individual nations, the Bill took on the force of international law."*

The words in the two paragraphs just above sound fine, and fine they look on paper as well, and on computer screens; but, the BIG TROUBLE seems to be that, to date, all (or almost all) of these human rights "Bills", human rights legal "Instruments", and so on, are NOT being policed, not being recognised by the legal professions, and consequently are NOT being enforced through the appropriate "courts of law" of the many nation-states who (in theory) have "adapted" these principles. Consequently, all the "fine words" seem to mean "little or nothing" as far as the PRACTICAL aspects of daily life, all over the world generally, at the present time, are concerned.

Is it all – so far – just a "cheap and nasty", and deceitful form of "window-dressing" designed to hoodwink ourselves (i.e. "humanity as a whole") into believing that the hugely important issue of "human rights" really is being treated seriously by our governments, and that "all is well" in this regard just now? Personally, and based on my own personal experiences (especially since mid-1998), I largely believe that we (i.e. "humanity as a whole") really are deceiving ourselves in the most unhealthy and dangerous of ways; and, I have also come to believe that, if "the people" of the world "know what's good for them" they, as INDIVIDUAL human beings, will put their "shoulders to the wheel" and, gently but firmly, peacefully and lawfully, "push" for their respective governments to ensure that all (or most at least) of the "human rights law theory" becomes a living reality, internationally. "Use it, or lose it!", and keep in mind that there might not be an unlimited amount of time for implementing such change: having due regard for the already decades-old, lurking threat of a thermonuclear WW3 (World War Three) starting up (either by accident or design) at literally any moment, at the hands of one or more of the many highly influential people (in and around a number of very powerful governments, and elsewhere) who appear to have nothing but total contempt for "human rights law"; a great fondness for promoting and implementing "regime change" (of a kind which involves human rights violations and abuses on a massive scale); and, very easy access to the vast sums of money required for initiating and sustaining "**divide and rule**" / "**might is right**" type conflicts and warfare of all kinds (large and small): thanks very largely, in more recent centuries especially, to all of the financial backing for such projects which is being provided by the "BANKSTERS".

Is the "**possibly now unstoppable (?) global runaway-trend**" towards **WORLD "Government of the Banksters, by the Banksters, for the Banksters"** really good for "**humanity as a whole**": as many people in and around our governments, and in our **very largely bankster-owned/controlled "Main Stream Media"**, would have the rest of us believe in, and support?
