

Allowing for the "proof" requested by the Housing Executive, I will also need to provide evidence of the overall sum of the monthly loans you have supplied me with to date against my home in New Inn village ("St Albans"). My hope is that you will be able to provide me with separate signed statements as to how much exactly, you have loaned me to date (against my home in New Inn): which I will forward to the Housing Executive, together with the other information they have requested.

In the "claim" I made for "Housing Benefit" of "August 10th 2015", referred to in the attached Housing Executive letter, I stated that I believed the overall total of the loans you have provided me with is in the region of 65,000 Euros: i.e. 20,000 Euros provided by Marjorie Dolan, and approximately 45,000 Euros provided by Gerald Finnerty (up to that time, "August 10th 2015"). I have also informed the Housing Executive that, without exception, all of the monthly loans you have provided me with were paid -- by cheque -- into my Allied Irish Bank account in Ballinasoe, County Galway.

In addition, I have also informed the Housing Executive, that the main reason for the present size of above-mentioned loans, relates to the fact that -- for no good reason whatsoever that I know of -- the Government of the Republic of Ireland has refused to pay me the old age pension I formally applied for on March 16th 2011; and, that much as I would like to do so, I still cannot find any legal representation of the kind that is willing to challenge, on my behalf, the Government of the Republic



of Ireland regarding this old age pension issue: as is also the case regarding a number of other extremely serious legal matters which I believe are indirectly related to the above-mentioned nonpayment of my old age pension by the Government of the Republic of Ireland.

With regard to the value of my home in New Inn village, and as I believe I have already informed you about, at the time, I made enquiries about 18 months ago, from a few local people who I knew were involved in attempts to sell local properties during the Spring of 2013; and, they advised me that due to the derelict state of my home in New Inn, it was probably only worth the value of the site: which they estimated would be in the region of Euros 50,000.


