Dear Paula,

Thank you for your email to me of this morning. I trust you will have since received my email reply to it (which I sent to you at 10.41 am).

Thank you also for your email to me dated March 1st 2016, a copy of which I have placed at the following www location:

In addition, I would like thank you for your efforts to mediate on my behalf regarding the return of my belongings from Patsy Heaney (Landlord at 31 Kilmorey Street, Newry), which I very much appreciate.

As I mentioned to you the last time I saw you, the big difficulty I have with Patsy Heaney's overall approach to the whole matter — a difficulty which is still very much ongoing for me — dates all the way back to the way he refused my requests to contact the PSNI (Police Service of Northern Ireland) on the afternoon of Monday, November 16th 2016, immediately following Paul Goodman's attempt to murder me at 31 Kilmorey Street, which took place in the presence of Patsy Heaney and his Manager John Hughes.

During the 30 minutes or so just after the above-mentioned murder attempt, which was recorded from a number of different angles by the high quality multi-camera digital CCTV Security System in use at 31 Kilmorey Street, I politely asked Patsy Heaney to report, to the PSNI (Police Service of Northern Ireland), the murder-attempt on my life on three or four separate occasions, which he absolutely refused to do. By refusing these requests of mine, he has ever since appeared to me (correctly or otherwise) to have been "perverting the course of justice" in a very major way (from my viewpoint), which has had a number of very negative consequences for me. As I understand it, and although I am not a lawyer, "perverting the course of justice" is a very serious criminal offence; and, allowing for the contents of your March 1st 2016 email to me, it appears (to me) that Patsy Heaney is very determined to, as I see it, keep on committing crime against me, by holding on to my belongings against my wishes, and, at the same time, demanding storage fees for doing so: all for no good reason that I know of, or can think of.

One of the "very negative consequences" for me referred to in the paragraph immediately above relates to what I see as my avoidable stay at the Canal Court Hotel from between November 20th 2015 to December 15th 2015, and the associated bill for £2,098.76 that I have had to pay for entirely, using money borrowed from close relatives. Later that same evening (December 16th 2015), I did report the murder attempt myself to the PSNI, and discussed the whole matter at considerable length with PSNI Investigating Officer Sheila Morton, and PSNI Constable Lee Macklin, in the reception area of the Francis Court Hotel, Newry (which I had booked into just a little earlier that evening). Also, at the end of a long meeting with Constable Lee Macklin (also in the reception area of the Francis Court Hotel) on the evening of Wednesday December 18th 2015, I signed the formal written statement he wrote out during the course of the meeting, which he then took away with him.

The PSNI Crime Reference Number is "E District, 918 dated 16/11/15".

After receiving your email of March 1st 2016 (referred to above), and allowing for the "maximum of a further two weeks" time-limit (set by Patsy Heaney) that is mentioned in it, I decided to try and get professional legal advise as soon as I possibly could on the matter; and, I succeeded in getting an appointment with Aoife McShane (Lawyer) at "McShane Solicitors" (Newry) for 3 p.m. last Monday (March 7th 2016).

At the end of last Monday's appointment with Aoife McShane (at approximately 4pm), and as I recall and understand the events that took place during the meeting, the following decisions had been agreed on between myself and Ms Aoife McShane:

- 1) Aoife McShane was to contact you regarding the nature of the agreement you had negotiated on my behalf with Patsy Heaney in connection with the return of my belongings. As far as I know, she was mostly interested in finding out from you if it was a written agreement, or if it was verbal.
- 2) Aoife McShane was to send a letter through the "recorded delivery" post to Patsy Heaney's Office (at 31 Kilmorey Street), and she was to later send me a copy of the text of the letter in question by email.
- 3) On learning from me that I have received some legal help (last year) from Newry law-firm "McGuigan and Malone" regarding other aspects of the overall set of legal difficulties I am at present struggling with, Aoife McShane pointed out to me that it was not possible to have two Newry law firms working on the same case, at the same time. Consequently, I signed a legal paper authorising her to arrange for all of my papers at McGuigan and Malone to be handed over to her. As I have already mentioned to you on a number of occasions, and for reasons unknown to me, I have not received any reply from "McGuigan and Malone" to any of the several written requests for legal help that I have made to them in recent months.
- 4) Aoife McShane was to contact the PSNI on my behalf for an update on the situation regarding the file that PSNI Investigating Officer Sheila Morton informed me (on December 11th 2015) she was preparing for the PPS (Public Prosecution Service). 5) Aoife McShane expressed an interest in seeing your email to me dated March 1st 2016, and I sent a copy of it as an attachment to the email I sent to her approximately 30 minutes after last Monday's appointment had ended. It would be much appreciated if you could please temporarily put everything to one side regarding the Homecare matters you wrote to me about this morning, until I am in receipt of the "recorded delivery" letter text referred to at 2) above from Aoife McShane.
