I wish you to know that I completely refute the allegation that I ever assaulted, or at any stage ever threatened to assault Garda Brendan Quirke (25502E) in any way whatsoever. It is also the case that I never had any wish to assault him, and that consequently that I never had any plans to assault him: ever.
