In case that for some reason you might not be aware of the "set of three registered letters" I sent to you, to Chief Police Commissioner Nóirín O'Sullivan, and to Chief Justice Susan Denham, all on May 13th 2015, I have asked my brother (Gerald Finnerty) and my half-sister (Marjorie Dolan) to take copies of all three of the registered letters in question to your Office today by hand.

I feel I should also point out to you that, as in your own case, it also appears to me that although I asked for the main matter to be treated as "urgent", Chief Police Commissioner Nóirín O'Sullivan, and Chief Justice Susan Denham, may also have decided possibly (?) to simply ignore the entire contents of my above-mentioned May 13th 2015 registered letters to them (as has already happened on a number of occasions in the past). To date, I have heard nothing at all from either of them, or from any of their support staff: not even "an acknowledgement of receipt": which, as I trust you will understand, is adding to my present concerns regarding the way the overall content of the three registered letters in question is possibly being handled by all three of you: at a time when the July 10th 2015 Loughrea District Court Hearing of my case is just six weeks or so away.

I am horrified by the contents of parts of your letter to me dated May 7th 2015: particularly those which relate to the "condition" that has been put in place whereby I must attend Loughrea District Court "on the said date (July 10th 2015) and failing same, a warrant will be issued for your arrest".

Allowing for the contents of the letter from me dated May 6th 2015 which my brother (Gerald Finnerty) and my half-sister (Marjorie Dolan) handed, on my behalf, to the Clerk of the Loughrea District Court on the morning of May 6th 2015 (well before the Court Sitting actually started I understand), and for the contents of the registered letter dated December 1st 2008 I sent to Police Superintendent Enda P. Walshe (who I understand is the Police Superintendent you have referred to in your letter to me dated May 7th 2015), I feel I have to ask you for legal advice on how I can go about challenging - well before July 10th 2015 the legality of the "condition" referred to above.

As you may already know, and in connection with my set of long-standing and growing "government wrongdoing" difficulties, Gerald and Marjorie had a meeting with Police Superintendent Enda P. Walshe a few years ago, and so they know him: and they believe he is the Superintendent you have referred to in your letter to me dated May 7th 2015.

Gerald and Marjorie have informed me that they also handed you a copy of my May 6th 2015 letter to the Clerk of the Loughrea District Court, well before the Court Sitting actually started, and that you took it away with you.



RE: DIRECTOR OF PUBLIC PROSECUTIONS CLAIRE LOFTUS-v-WILLIAM FINNERTY AT LOUGHREA COURT 6TH MAY 2015

I am horrified by the contents of parts of your letter to me dated May 7th 2015: particularly those which relate to the "condition" that has been put in place whereby I must attend Loughrea District Court "on the said date (July 10th 2015) and failing same, a warrant will be issued for your arrest".

Allowing for the contents of the letter from me dated May 6th 2015 which my brother (Gerald Finnerty) and my half-sister (Marjorie Dolan) handed, on my behalf, to the Clerk of the Loughrea District Court on the morning of May 6th 2015 (well before the Court Sitting actually started I understand), and for the contents of the registered letter dated December 1st 2008 I sent to Police Superintendent Enda P. Walshe (who I understand is the Police Superintendent you have referred to in your letter to me dated May 7th 2015), I feel I have to ask you for legal advice on how I can go about challenging - well before July 10th 2015 the legality of the "condition" referred to above.

As you may already know, and in connection with my set of long-standing and growing "government wrongdoing" difficulties, Gerald and Marjorie had a meeting with Police Superintendent Enda P. Walshe a few years ago, and so they know him: and they believe he is the Superintendent you have referred to in your letter to me dated May 7th 2015.

Gerald and Marjorie have informed me that they also handed you a copy of my May 6th 2015 letter to the Clerk of the Loughrea District Court, well before the Court Sitting actually started, and that you took it away with you.

I am horrified by the contents of parts of your letter to me dated May 7th 2015: particularly those which relate to the "condition" that has been put in place whereby I must attend Loughrea District Court "on the said date (July 10th 2015) and failing same, a warrant will be issued for your arrest".

Allowing for the contents of the letter from me dated May 6th 2015 which my brother (Gerald Finnerty) and my half-sister (Marjorie Dolan) handed, on my behalf, to the Clerk of the Loughrea District Court on the morning of May 6th 2015 (well before the Court Sitting actually started I understand), and for the contents of the registered letter dated December 1st 2008 I sent to Police Superintendent Enda P. Walshe (who I understand is the Police Superintendent you have referred to in your letter to me dated May 7th 2015), I feel I have to ask you for legal advice on how I can go about challenging - well before July 10th 2015 the legality of the "condition" referred to above.

As you may already know, and in connection with my set of long-standing and growing "government wrongdoing" difficulties, Gerald and Marjorie had a meeting with Police Superintendent Enda P. Walshe a few years ago, and so they know him: and they believe he is the Superintendent you have referred to in your letter to me dated May 7th 2015.

Gerald and Mariorie have informed me that they also handed you a copy of my May 6th 2015 letter to the Clerk of the Loughrea District Court, well before the Court Sitting actually started, and that you took it away with you.
