Dear Mr McGuigan,

**RE: THE POSSIBILITY OF MAJOR MISUNDERSTANDINGS CAUSED BY LETTERS SENT TO ME WHICH I MIGHT NOT HAVE RECEIVED**

Thank you for your letter dated **June 28th 2016** which was attached to the email I received from "**McGuigan Malone Solicitors**" Legal Assistant **Ashley Copas**, which is also dated June 28th 2016.

The main reason I'm writing to you just now is because the **"31 Kilmorey Street"** postal address you have used for me in your June 28th 2016 letter to me is **incorrect**.

Following a failed murder attempt on my life on **November 16th 2015**, I suddenly left the 31 Kilmorey Street address; and, as you may already know, the tenancy agreement I entered into with local (Newry) landlord **Mr Patsy Heaney** (who is the owner of **Clanrye Properties** I understand) in August 2015 has never -- as far as I'm concerned at least -- been lawfully terminated. I have long believed that, allowing for the complications caused by the murder attempt on my life on November 16th 2015, which is not covered for in the formal tenancy agreement I entered into with Patsy Heaney, the services of a professional lawyer, who is willing to take full account of all the relevant and closely associated facts relating to the murder attempt in question, is required: if the tenancy agreement in question is ever to be terminated in a lawful and just manner; and, although I feel I have tried very hard to find such legal representation, I have so far failed to locate it.

One of the several negative consequences of my sudden departure from the "31 Kilmorey Street" address, and the ongoing termination difficulties relating to the associated tenancy agreement, is that several letters sent to me since November 16th 2016, via the normal **Royal Mail** postal service, and using "31 Kilmorey Street" address, have not been received by me. I have reason to believe that the numbers of letters in question (which I have not received) would amount to several dozen.

Further information and evidence relating to my ongoing efforts to have the above-mentioned tenancy agreement lawfully terminated by a professional lawyer can be viewed in the scanned copies of the two **registered letters** at the www locations provided immediately below -- the **first** dated **April 4th 2016**, and the **second** dated **May 9th 2016** -- which I have sent to **Mc Shane's Law Firm** (Newry):

In case you might not be aware of it at the present time, please know that in the weeks following the above mentioned murder attempt of November 16th 2015, I set up a **"Poste Restante"** address at the **Hill Street (Newry) Post Office**; and, that I related this fact to your colleague **Louise Moley LL.B.** in an email I sent to her on **December 14th 2015**. A full copy of the December 14th 2015 email in question, which was titled **"File to be submitted to the PPS (Public Prosecution Service)"**, can be viewed at the following www location:

Changing the subject slightly, please know that I have included my present **"temporary/emergency"** address (in Newry) in the **"printed and signed"** copy of the **June 23rd 2016** email I sent to your colleague (Louise Moley LL.B.) through the registered post (also on June 23rd 2016); and, that scanned copies of the registered letter in question, together with scanned copies of the associated Royal Mail receipt, and the associated **Royal Mail "Proof of Delivery"** note can all be viewed at the following www location:

The main reason I'm pointing out this matter of the June 23rd 2016 **registered letter**, is that your June 28th 2016 letter to me (referred to above close to the very top of this message text) contains no mention at all of my **June 23rd 2016 registered (and "signed for") letter to "McGuigan and Malone Solicitors"**; and, my concern just now is that -- for one reason or another-- you might not know anything at all about it, or about my present postal address: which I **"hand wrote"** onto **Page 5**, at the www location provided immediately above, with two lines of the my present address "blacked out" in the copy published on the www system, **but, which were not blacked out on the version I sent through the Royal Mail Postal Service** on June 23rd 2016.

There are some other comments I would like to make to you relating to the contents of your June 28th 2016 letter to me (referred to above), and it is my intention to write to you again within the **coming 14 days** regarding them.

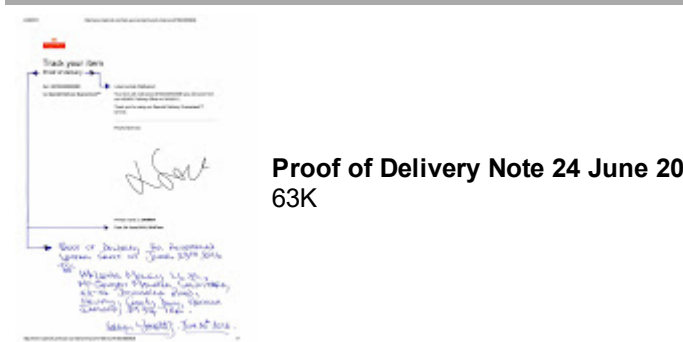
