Dear Dr Radcliffe,

As you may know, I have had an appointment at Daisy Hill Hospital with Consultant Clinical Psychologist Dr Elizabeth McMonagle, and Trainee Clinical Psychologist Madeline Fitzpatrick, on April 19th 2016.

Please find attached the duplicate of a "marked up" copy of Dr Michael McCavert's "To Whom It May Concern" letter" dated October 28th 2005, which contains some handwritten notes I had added before the appointment, and which, following some discussion, I left with Dr McMonagle and Madeline Fitzpatrick at the end of the appointment.

As can be seen on the attached "marked up" copy of Dr McCavert's October 28th 2005 letter, I listed two requests that I wish to make to the medical profession, which I feel very badly in need of at the present time.

REQUEST #1 (which is for an update of Dr Michael McCavert's "To Whom It May Concern" letter dated Oct 28th 2005):

Assuming I understood Dr Elizabeth McMonagle correctly on April 19th 2016, she suggested that I should write to you for the purpose of making my request to the medical profession, for the updated version of Dr McCavert's "To Whom It May Concern" letter" dated Oct 28th 2005 that I now seek, and which will, I hope, assuming this request of mine is granted, be signed by Consultant Psychiatrist Dr Mark McCauley.

As I believe you will probably have been informed, I have already had two "Mental Health Assessment" appointments with Consultant Psychiatrist Dr Mark McCauley, the first of which was on December 3rd 2015, and the second on January 7th 2016. As I understand it, Dr McCauley requested the second appointment for my assessment because he felt my situation was too complex for him to fully complete my "Mental Health Assessment" in the first session; and, at the end of the second appointment, and because he then seemed to feel that some of the difficulties I was experiencing were outside "the normal run of things" (as far as his work experience is concerned), he asked me if I would be happy about allowing him to get a "second opinion", which I agreed to. This resulted in the initial meeting I have had with Trainee Clinical Psychologist Madeline Fitzpatrick on March 14th 2016, which was followed up by the appointment with Consultant Clinical Psychologist Dr Elizabeth McMonagle, and Trainee Clinical Psychologist Madeline Fitzpatrick, on April 19th 2016 (referred to above).

REQUEST #2 (which is for "talking therapy" with a suitably qualified therapist for what I believe is the "Chronic Post Traumatic Stress Disorder" that I have been suffering from since around year 2000, some 5 years or so before Dr Michael McCavert GP provided me with his "To Whom It May Concern" letter dated Oct 28th 2005):

Regarding this request, Trainee Clinical Psychologist Madeline Fitzpatrick assured me (during the April 19th 2016 appointment) that she has received the necessary training to provide me with the "talking therapy" I seek, and I understand that another appointment will be made for me to see her again, sometime in the coming few weeks.

Also enclosed, please find the copy of a two-page letter I sent last Friday (April 22nd 2016) to my half-sister (Marjorie Dolan) who is now in her 84th year, and my brother (Gerald Finnerty) who is now in his 77th year. My hope is that the general contents of this letter might help you and your colleagues in the medical profession to better understand the way I feel regarding my present overall situation, and my present set of

personal priorities.

There is reference in the April 22nd 2016 letter to the money I have needed to borrow from my brother and half-sister since 2007, and the total sum I have borrowed from them now stands at Euros 71,000. Of the Euros 71,000 in question, 20,000 have been loaned to me by my half-sister, and my brother has loaned me the remaining 51,000. As indicated in my April 22nd 2016 letter (to my brother and half-sister), I always felt a great sense of duty to pay back all of the money that my brother and half-sister have loaned to me since 2007, and to do so as soon as I possibly can.

As can also be seen towards the end of the enclosed copy of my April 22nd 2016 letter to my brother and half-sister, there is reference to a registered letter I sent to local (Newry) lawyer Aoife McShane on April 4th 2016, which I have not received any reply for to date, even though the Royal Mail "Track and Trace" Postal Service indicates that the letter was successfully delivered on April 5th 2016. I am growing very concerned about the possibility that McShanes law-firm may have decided to completely ignore both the contents, and the entire existence perhaps, of my registered letter to Aoife McShane of April 4th 2016. This concern of mine is closely linked to the fact that since 1998, when I first got involved in pointing out the extremely serious "government wrongdoing" (by the Government of the Republic of Ireland), which I began to discover around that time, I have on several occasions since then had the very disturbing experience of having registered letters I sent to law firms, lawyers (including judges), politicians, police officers, and medical doctors, completely ignored by them; and, it is responses of that particular kind, more than anything else, which I believe have been the primary cause of the Chronic Post Traumatic Stress Disorder I have been suffering from since around 2000, and which -- to date -- I have never had any proper "talking therapy" type of medical treatment for. Far more importantly, neither have I ever had any proper legal representation (to date) for the purpose of defending myself against the criminal attacks (as I see them) being made against me by the Republic of Ireland Government, which, among other things, involve completely false claims that I have committed crime in the Republic of Ireland, the blocking of my old age pension (since 2011), and a number of lengthy periods of living in "forced exile" outside the Republic of Ireland (since 2002), which, in the absence of any proper legal representation, has been the only way I have been able to avoid being wrongly criminalised, and possibly imprisoned, in the Republic of Ireland.
