Preliminary accommodation offer from Helm Housing

A misunderstanding appears to have arisen relating to the fact that, at the end of my conversation with Portadown Housing Officer John Hughes on August 26th 2016 (in Portadown), it was my understanding that from that point in time onwards, all following offers of accommodation for me from the Housing Executive would be handled by Ms Julianne Milligan (at the Portadown Housing Executive Office); and, that if there was a need for communications regarding my particular case, between the Portadown Housing Executive Office and the Newry Housing Executive Office, that Julianne Milligan, or one of her support staff, would also deal with all such communications directly, and without the need for any involvement on my part.

In her letter dated September 20th 2016, a copy of which I have received as an attachment to a letter dated September 22nd 2016 from Mr Ronan Haughey (Lawyer), of M. L. White Solicitors (Newry), it seems clear that Julianne Milligan wishes me to communicate directly with the Newry Housing Executive Office, and not with her.
