I have been finding it extremely difficult to decide how best to respond to your April 1st 2020 email (at the www location immediately above), and this is mostly because of the fact that it contains no mention at all of the letter I sent to you through the registered post on March 16th 2020.

If for some reason you are personally unaware of the March 16th 2020 registered letter I have sent to you, please know that a scanned copy of it, together with scanned copies of the associated Royal Mail receipt, and the Royal Mail "Proof of Delivery" note can be viewed at: <http://www.humanrightsireland.com/RadiusHousing/16March2020/MrsDeborahSparks/RegisteredLetter.htm>

It would be much appreciated if you could please provide me with written confirmation that you have received the registered letter I sent to you on March 16th 2020.

I now feel I should also point out that there is another registered letter, which I strongly suspect you might also be personally unaware of, that I sent to Radius Housing Association Officer Mr John Cairnduff on October 21st 2019. Please know that a scanned copy of the letter in question, together with scanned copies of the associated Royal Mail receipt, and the Royal Mail "Proof of Delivery" note can be viewed at: <http://www.humanrightsireland.com/RadiusHousing/21October2019/RegisteredLetter.htm>

It would be much appreciated if you could also please provide me with written confirmation that you are aware of the contents of the October 21st 2019 registered letter to Mr Cairnduff referred to at the www location immediately above.

With further reference to my October 19th 2019 registered letter to Mr J Cairnduff, and from the viewpoint of

resolving my Radius Housing Association rent arrears problem, I believe it might help greatly if you were to use the [www](#) link provided at the [www](#) location immediately above, to take note the contents of the registered letter I sent to **Consultant Psychiatrist Dr Paul Bell** on **November 3rd 2018**, in which I listed many of the unresolved difficulties I am still struggling with, and which -- for some reason/s unknown to me, but which are nonetheless an ongoing source of great concern to me -- Dr Paul Bell has apparently decided to completely ignore. Should you wish to examine this list, I believe it might also help if could also keep in mind the **"Duty of Care"** issue, which, as I understand it, has major implications relating to the legal matter of **"criminal negligence"**, that I raised under the "RELATED GOOGLE LISTING" heading at the end of the registered letter I sent to you on March 16th 2020 (referred to above).
