EXCERPTS FROM EMAIL TO THE NORTHERN IRELAND LAW CENTRE DATED AUGUST 4th 2017:

Item #3: DEEP PUZZLEMENT for me regarding the policing and the enforcement of European Union Human Rights Law in both Northern Ireland, and in the Republic of Ireland

The text of Article 47 of THE CHARTER OF FUNDAMENTAL RIGHTS OF THE EUROPEAN UNION:

"Right to an effective remedy and to a fair trial"

"Everyone whose rights and freedoms guaranteed by the law of the Union are violated has the right to an effective remedy before a tribunal in compliance with the conditions laid down in this Article.

"Everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal previously established by law. Everyone shall have the possibility of being advised, defended and represented."

"Legal aid shall be made available to those who lack sufficient resources in so far as such aid is necessary to ensure effective access to justice."

Why, I frequently find myself wondering, allowing for the text just above, and other similar human rights law texts, am I having such enormous difficulty, over a period of several years, i.e. since well before I received the attached "To Whom It May Concern" letter dated October 28th 2005 from Dr Michael McCavert GP, with finding legal representation regarding, for example, the extant warrant for my arrest which apparently exists in the Republic of Ireland?

The difficulties for me with finding legal representation, as related in the section immediately above, remain entirely unresolved.

Could they have been very largely, if not entirely, avoided?

Are there useful lessons to be learned for the future regarding the shoddy way that so many public officials and bodies still appear, in practice, to be more or less completely ignoring the principles set out in the **United Nations Universal Declaration of Human Rights**, and in all of the closely associated national and international legislation produced since 1948 in support of such basic human rights principles: such as, for example, in THE CHARTER OF FUNDAMENTAL RIGHTS OF THE EUROPEAN UNION referred to above?

There is no good reason now, or ever again, for people and nations to have to resort to physical violence as a means for settling their disputes?

'The Troubles (Irish: Na Trioblóidí) was an ethno-nationalist[12][13][14][15] conflict in Northern Ireland during the late 20th century. Also known internationally as the Northern Ireland conflict,[16][17][18][19][20] it is sometimes described as a "guerrilla war" or a "low-level war".[21][22][23] The conflict began in the late 1960s and it is usually deemed to have ended with the Good Friday Agreement of 1998.[3][24][25][26][27] Although the Troubles mainly took place in Northern Ireland, at times the violence spilled over into parts of the Republic of Ireland, England and mainland Europe.
