RE: HELP REQUIRED FOR DISABILITY BENEFIT APPLICATION

Thank you for seeing me last Friday afternoon.

As I mentioned to you on Friday, I feel I will need guidance and help regarding the matter of applying for Disability Benefit relating to the **C-PTSD (Complex-Post Traumatic Stress Disorder)** I am suffering from.The application form I have been sent by **The Department for Communities** is titled:**"Disability and Carers Service, Attendance Allowance for people of State Pension age or over"**.
(Form Number: AA1, Version 02/18)

My main concern just now is that, despite my best efforts over a period of several years, I am still not receiving any proper treatment for the C-PTSD I am suffering from.

Evidence of my being diagnosed as suffering from C-PTSD can be found in the letter written by **Consultant Psychiatrist Dr Paul Bell** in his letter (copied to me) dated **November 27th 2018**, a scanned copy of which can be viewed at the following www location:<http://www.humanrightsireland.com/ConsultantPsychiatristDrPaulBell/27November2018/Letter.htm>Information relating to my most recent attempt to get treatment for the C-PTSD I am suffering from can be found in the text of my letter dated **August 2nd 2019** to **Psychiatric Nurse Helen Elder** (Talking Therapies and Wellbeing Mental Health Hub, Belfast), a scanned copy of which can be viewed at:<http://www.humanrightsireland.com/WellbeingHubBelfast/2August2019/RegisteredLetter.htm>

Please know that, to date, I have not received any reply of any kind from Nurse Elder, or from any of her colleagues at the Wellbeing Mental Health Hub.

As I mentioned to you last Friday, I have received Disability Benefit for the C-PTSD I am suffering from on two separate occasions in the past. More information relating to the "stop/start" circumstances in question can be found in **Section 7** of my letter to **Consultant Psychiatrist Dr Paul Bell** dated **November 3rd 2018**, a scanned copy of which can be viewed at:<http://www.humanrightsireland.com/ConsultantPsychiatristDrPaulBell/3November2018/RegisteredLetter.html>I feel I should also point out that my need to apply for Disability Benefit has grown much more pressing in recent weeks, and that this is due to the fact that my **Pension Credit** payments, and my **Housing Benefit** payments, have both now been fully cancelled. Cairnduff** at **Radius Housing Association**, a scanned copy of which can be viewed at:<http://www.humanrightsireland.com/RadiusHousing/21October2019/RegisteredLetter.htm>Also, I can now confirm that I definitely did, several years ago, seek help from **Victim Support NI** (which you asked me about last Friday), and that they were unable to help me in any significant overall way, though they did help me in a number of smaller ways.
